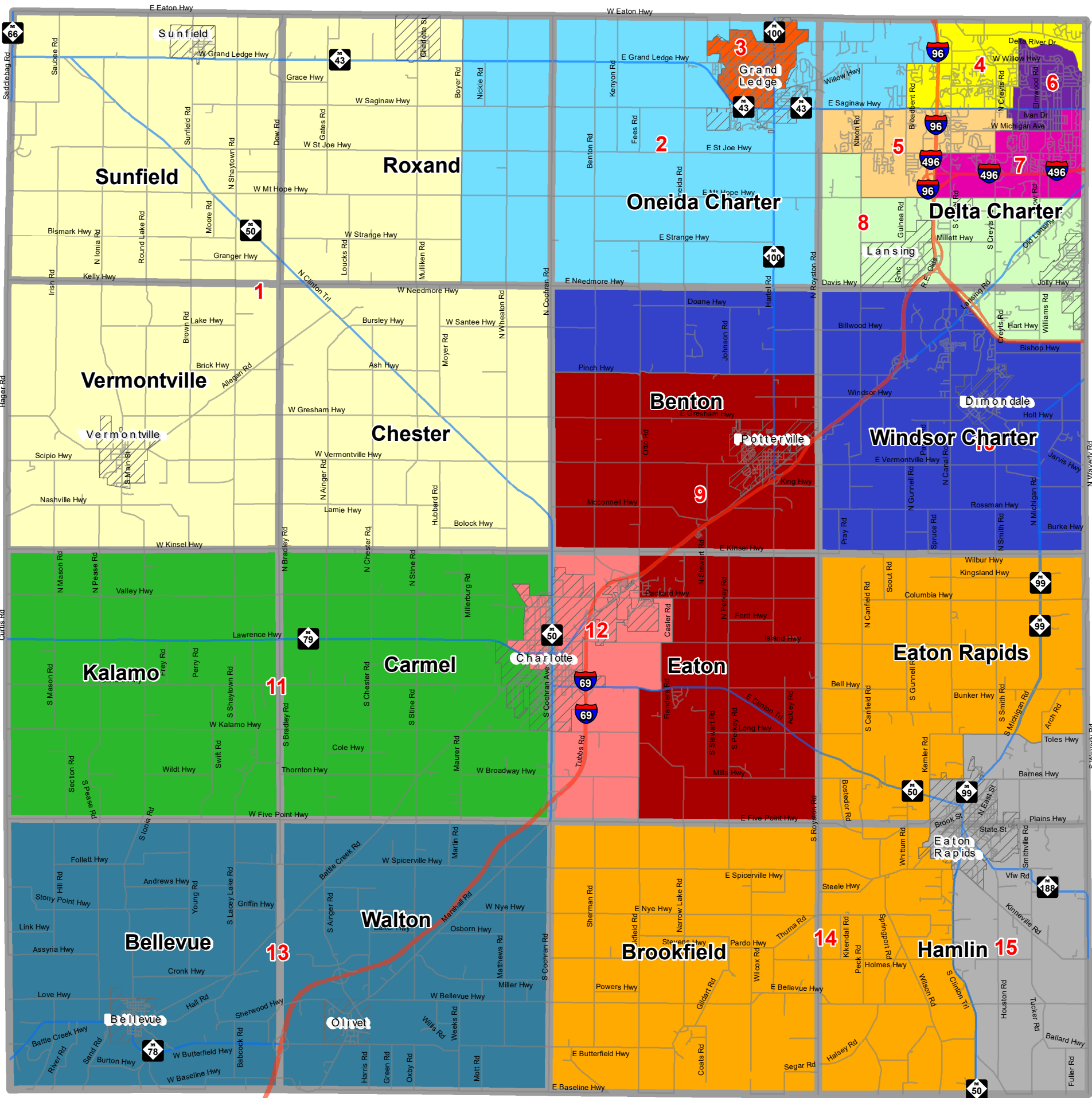

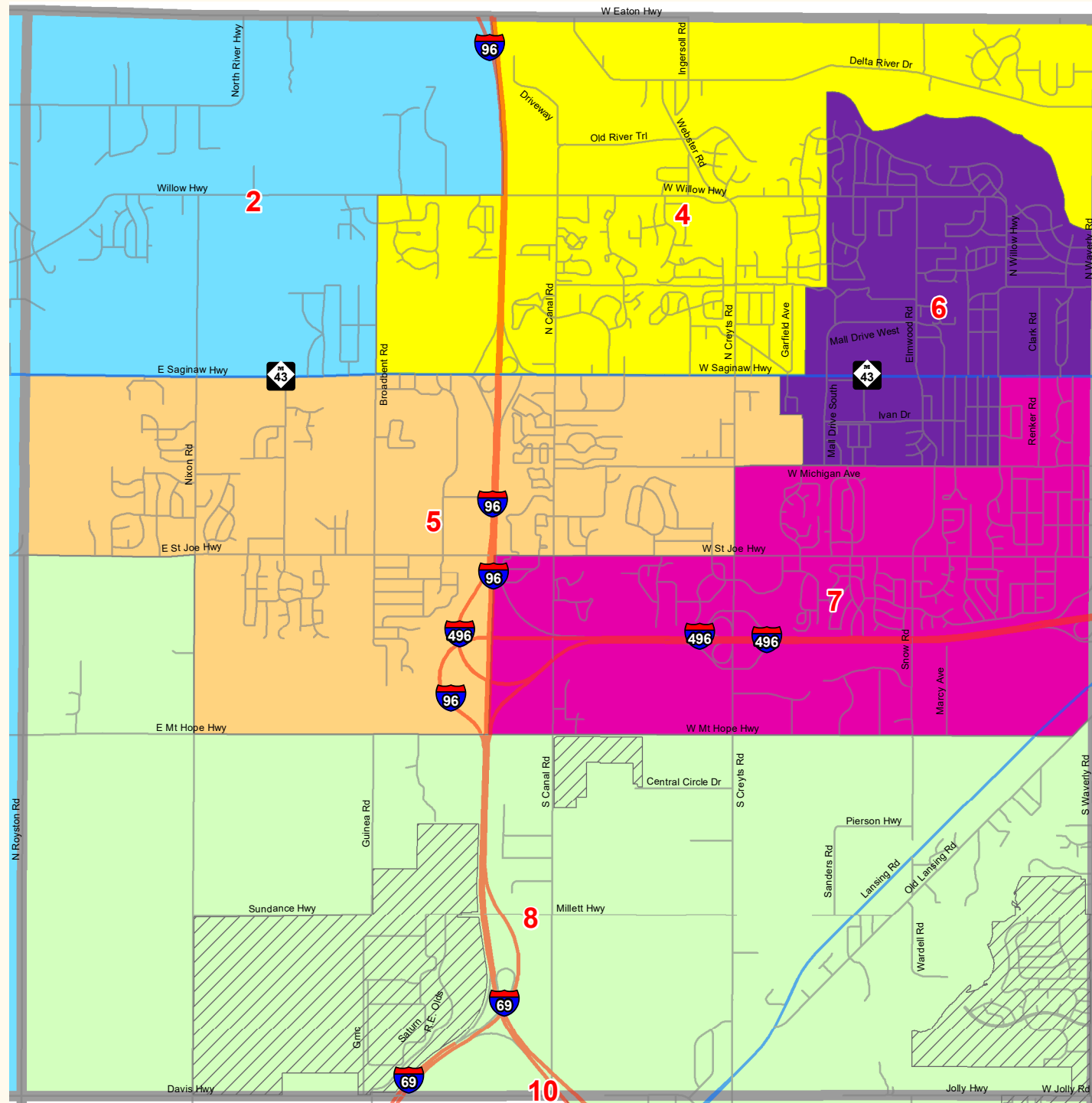

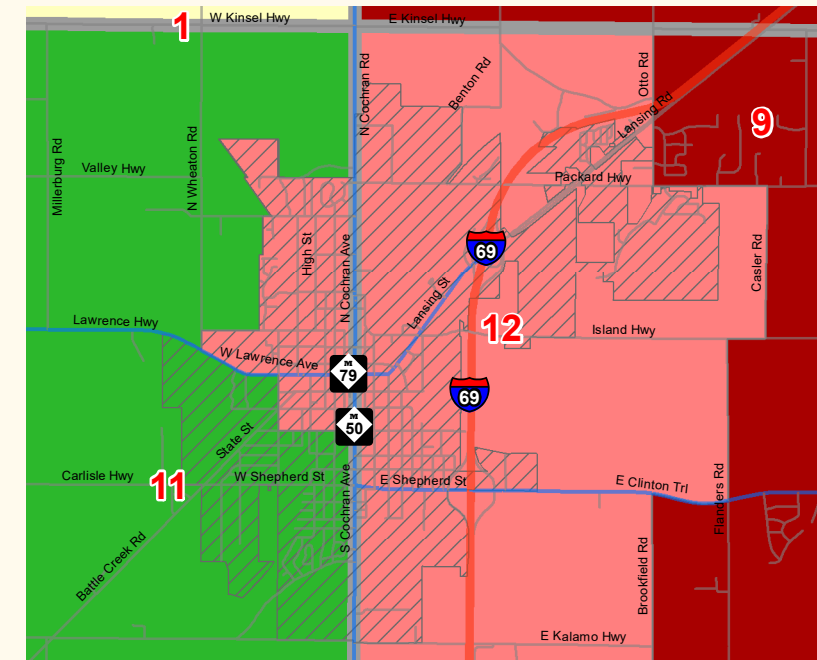

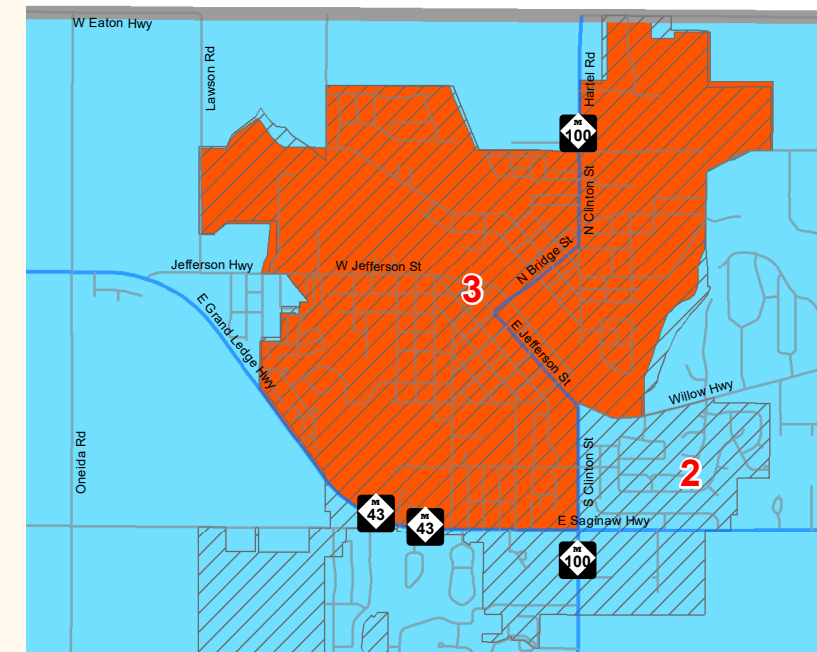
## Inset Map of Delta Charter Township
