## **Digital Device Use Policy**

### **Eaton County Parks**

We encourage families and youth to embrace technology in our summer youth programs as it provides a way for families to keep in touch, encourages children to share their excitement and pictures with their parents during the program, encourages children to use educational programs or take pictures on their device during field trips that they can later use in power point presentations.

We just ask that the kids use their device responsibly. There are two times: mid-morning and mid-afternoon when the kids can use their cell phone to check in by calling or texting. However, we do ask that they only text or call home or a caregiver. This is not time to socialize with friends over the phone.

We ask the kids to keep their phone silenced and to not text their friends and family for the rest of the day. If a parent or caregiver needs to contact a child in an emergency or urgent situation, please call Teddy Short on her cell phone (269-986-1639) which is always turned on and serves as the contact and emergency number for the youth programs.

We also encourage the kids to use digital cameras responsibly. We do have a limited number of digital cameras available for use.
